5. For remittance of fee in US Dollars to the FBISE, the overseas candidates may exercise one of the following options:-

a. Payment may be made through Bank Draft in favour of Controller of Examinations (Conduct), Federal Board of Intermediate & Secondary Education, Islamabad, encashable at Islamabad. **Bank Draft encashable from USA will not be accepted.**

8. The compartmental candidates of SSC Annual Examination, 2017, who receive the pre-print Computerized Admission Forms shall sign the Admission Form, deposit the required fee, enter the Bank Draft Number/SWIFT transaction reference at the given place and submit to the Board by post. However those candidates who do not receive Computerized Admission Form shall download Computerized Admission Forms from FBISE website i.e. www.fbise.edu.pk and shall sign the Admission Form, deposit the required fee, enter the Bank Draft Number/SWIFT transaction reference at the given place and submit to Board by post. These forms will not require any attestation.

9. Those candidates whose result is declared late by the Board may submit their Admission Forms with normal fee within 15 days from the date of declaration of their result but before commencement of Examination.


FOR IMPROVEMENT CASES:-

10. The candidates who intend to improve their Grade/Marks after passing SSC Examination can do so by re-appearing in any number of subjects/papers of their choice or part-I or Part-II or both the Parts/entire examination as the case may be within a period of one year of passing the relevant examination. The candidates should fill in the Admission forms which can be downloaded from FBISE web-site i.e. www.fbise.edu.pk.
