**Subject: CO-CURRICULAR AND STEM ACTIVITIES FOR THE SESSION 2024-25**

Co-curricular activities, apart from supplementing the main curricula and syllabi, are also imperative for the overall development and grooming of students. FBISE, considering such activities as part of its responsibilities, provides opportunities to the students of its affiliated institutions to participate in Co-curricular activities every year. In this regard, Intra-Board competitions in Qirat, Naat, Urdu & English Speeches, National Songs (Milli Naghmey) at SSC and HSSC levels and STEM activities (Science Exhibition) at HSSC level are held under the umbrella of Academic week.

In view of the above, you are requested to hold the competitions of Qirat, Naat, Urdu & English Speeches, National Songs (Milli Naghmey) at SSC and HSSC levels amongst the students of your institutions and forward the names of 1st and 2nd position holders, including boys and girls of each event to this office by **3<sup>rd</sup> October, 2024**, positively. The Board intends to hold its Academic Week with effect from **18<sup>th</sup> November 2024**. Names forwarded directly by the Schools / Colleges will **NOT** be entertained. You are further requested to organize STEM activities (Science exhibition) for HSSC level students of your institutions in the subjects of Physics, Chemistry, Biology, Computer Science and Mathematics. Areas like coding, gamification of science and robotics etc. may be specifically included apart from other related fields/domains of science subjects mentioned above. The names of panel /students (not more than three students per panel) of the 1st and 2nd position holders in each subject, irrespective of gender, may also be sent to this office by **3<sup>rd</sup> October, 2024**, at HSSC Level. The selected students may be advised to display their models in the auditorium of the FBISE one day before the scheduled date as per calendar. Schedule of the Co-curricular and STEM activities containing all the relevant details and proforma for forwarding names of the students for the competitions are enclosed herewith.

3. A teacher (Supervisor) may also accompany the student(s).

4. All the concerned are requested to fill the performa available on the weblink: [www.fbise.edu.pk/activities.php](http://www.fbise.edu.pk/activities.php) and also send hard copy of the same to FBISE so that we may start the competitions as per schedule.
