3. Fee should be remitted in any branch of Habib Bank Ltd. (Within Pakistan) through computerised Bank challan slip which is being sent along with computerized Admission forms. However, it can also be downloaded from FBISE Website i.e. [www.fbise.edu.pk](http://www.fbise.edu.pk). Original Board copy of fee challan must be attached along with the admission form.

4. The pre-printed Computerized Admission Forms of failure regular candidates of HSSC Annual Examination, 2019 are being sent to the Heads of Institutions concerned who will issue the same to the failure candidates along with their Result Cards. The pre-printed Computerized Admission Forms of the Ex/Private failure candidates are being dispatched on their addresses given by them in their Admission Forms. However, those candidates who do not receive Computerized Admission forms shall download Computerized Admission forms from FBISE Website i.e. [www.fbise.edu.pk](http://www.fbise.edu.pk).



Candidates failing at HSSC-II Annual Examination 2019, (compartment cases) who receive the pre-printed Computerized Admission Forms shall deposit the required fee, enter the Challan Number, write the postal address, contact number & sign the Admission Form at the given place and submit to the Board. These forms will not require any attestation.

6. **NO FRESH CANDIDATE IS ALLOWED TO APPEAR IN SUPPLEMENTARY EXAMINATIONS.** However, those candidates who intend to improve their Grade/Marks or want to take exam in Additional Subject(s) are eligible to appear in Supplementary Examination. Admission Form can be obtained from the Board's office or can be downloaded from FBISE website i.e. www.fbise.edu.pk.


7. Those candidates whose result is declared late by the Board may submit their Admission Forms with normal fee within 15 days from the date of declaration of their result but before commencement of the Examination.

8. The candidates of Gilgit may submit their Admission Forms to FBISE Sub Office, Gilgit (Gilgit-Baltistan) and the candidates of Skardu area may submit their Admission Forms to FBISE Sub-Office, at Public School and College, Skardu (Gilgit-Baltistan), as per admission schedule.
