2. The following categories of students will be eligible to appear in SSC 02<sup>nd</sup> Annual Examination 2022: -
- All the registered candidates of SSC I & II up to March, 2022 (Regular/Ex/Private) whose admission form was cancelled/not submitted for SSC 1<sup>st</sup> Annual Examination 2022, due to any reason are eligible to apply for SSC 02<sup>nd</sup> Annual Examination 2022.
  - All those registered candidates of SSC I & II up to March, 2022 who submitted their admission form for SSC 1<sup>st</sup> Annual Examination 2022 but remained full absent in SSC 1<sup>st</sup> Annual Examination 2022 for any reason are eligible to apply for SSC 02<sup>nd</sup> Annual Examination 2022.
  - The candidates who intend to improve their Grade/Marks after passing SSC Examination can do so by re-appearing in any number of subjects/papers of their choice of Part-I or Part-II or both the Parts/entire examination. The candidates appearing in any subject (both the papers) involving practical examination shall appear in the practical examination as well. However, candidate neither requires nor can appear in practical if he/she is appearing in a paper of a subject or any one part of the examination.
  - IBCC candidates are eligible to appear in SSC 2<sup>nd</sup> Annual Examination 2022.
  - Passed candidates of SSC-I 1<sup>st</sup> Annual Examination 2022 can appear for improving the marks/grade.
  - Compartment candidates of SSC-I are eligible to appear in SSC 2<sup>nd</sup> Annual Examination 2022
  - Change of subjects/group will not be allowed under any circumstances after final submission of online admission form to the FBISE's Office.
  - All the Heads of affiliated institutions are requested to ensure that the particulars of candidates on the admission forms are recorded on the basis of registration cards. Online admission form(s) will not be entertained / accepted without registration number(s).
  - Admission fee shall be remitted at any nearest Habib Bank Limited (HBL), Bank Muslim Commercial Bank (MCB) Branches and through Easy Paisa application. The scanned copy of remitted examination system generated fee challan must be deposited within due dates, as mentioned above.

### 3. MODE OF SUBMISSION FOR REGULAR CANDIDATES OF SSC-I & II.

Admission data (in soft form) placed on FBISE website for SSC-I & II candidates will be filled in letter and spirit by the institution and submitted online only within specified due dates. No hard/printed copy of admission form and documents (if any) of SSC-I & II regular candidates shall be sent by institution(s) to FBISE office by post.
